Clean Energy Lobby Day in Frankfort

The snow-delayed annual Clean Energy Lobby Day was finally held on February 26th in Frankfort at the Capital Annex. At least 35 individuals and a significant number of the member organizations of the [Kentucky Sustainable Energy Alliance \(KySEA\)](#), the overall organizer of the event, met with 26 Kentucky legislators or their staff advisers during the course of the day. During the event, at least four legislators agreed to co-sponsor our primary topic of the day, [House Bill 195, the Clean Energy Opportunity Act](#), sponsored by Rep. Mary Lou Marzian of Louisville. This bill establishes a Renewable and Efficiency Portfolio Standard (REPS), incrementally reaching 12.5% and 10.25% over 10 years, for most of the regulated electric utilities in KY, as well as a distributed generation feed-in tariff (FIT), somewhat similar to what TVA's customers already have available. The legislation is estimated to create 28,000 new clean energy jobs in KY for performing home improvements, renewable installations, and manufacturing, etc., plus will reduce the previously forecasted increase coming to Kentucky's electricity prices. And with no tax or budget increases.

Other legislation was also discussed during the event, including: [HB404](#), a Property Assessments for Conservation and Energy (PACE) improvements bill recently introduced by Rep. James Kay of Lexington; [SB70](#) from Senator Stan Humphries to further reduce energy use in state owned and leased buildings; and a potential improvement to the current net-metering regulation with Rep. Steve Riggs, who previously sponsored this in the 2012 session.



The day ended with a readout on the discussions with legislators, and a planning session for the March 6th hearing of HB195 in front of the House Tourism and Energy Committee.

Solar Installation in Kentucky Welcome New KySES

Members!



The Richardsville Elementary in Warren country KY was completed in 2010 and has 344kW of solar PV installed by Morton Solar. The site has two arrays: one using thin-film technology on the roof, and the other with 700 modules mounted on a parking structure. The school was designed with greater insulation, reduced air leakage, geothermal heating and cooling, efficient lighting that takes maximum advantage of day-lighting, and many other conservation and sustainability features. To date, they have produced over 1 gigawatt-hours. Since the school has a Power Purchase Agreement (PPA) with the Tennessee Vally Authority (TVA), they sell their production for a premium above retail, and they've received cash back each year so far.
